GENERAL INFORMATION

Cell Power® Calcium Gold can be used in combination with water soluble plant nutritional products which are formulated for foliar, sidedress or drip irrigation application. May be applied alone or in tank mixes containing fertilizers, fungicides and/or pesticides. **Cell Power® Calcium Gold** is believed to be compatible with most agricultural water-soluble plant nutritional products. If physical compatibility with another fertilizer product is unknown, use a jar compatibility test. When applying **Cell Power® Calcium Gold** blend as a foliar spray, always use a spreader penetrant. **ONCE PRODUCT IS DILUTED, USE WITHIN 24 HOURS.**

DIRECTIONS FOR USE

Citrus & Avocados: 1-4 quarts/acre. Apply after first flush in spring. Repeat applications every 2-4 weeks as necessary.

Field & Vegetable Crops including Hops: 1-4 quarts/acre. Begin applications when plants are 6-8 inches in size.

Deciduous Fruit & Nut Crops: 1-4 quarts/acre. Apply as needed throughout the growth season.

Grapes & Berries: 1-4 quarts/acre. Apply as needed during periods of active growth.

Turf: 0.5 to 1.0 fluid ounces per 1,000 sq. ft. Weekly applications as needed.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to the target area and sweep any product that lands on the driveway, sidewalk, or street, back into the target area.

Ornamental Tree, Shrubs and Flowering Plants: Apply at dilution rate of 3 ounces in 1 gallon of water. Spray to run off. Apply as needed at spray intervals of 14 days or more.

SOIL APPLICATION RECOMMENDATIONS

Apply **Cell Power® Calcium Gold** on all soil types at a rate of 1 quart to 2 gallons per acre. This material should be diluted prior to application through any irrigation system. Perform a jar test to ensure compatibility with the irrigation water source.

STORAGE AND DISPOSAL

STORAGE: Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures.
